NOTICE is hereby given that an Extra-Ordinary General Meeting No. (EOGM NO. 01/2019-20) ("EoGM") of the members of Poojawestern Metaliks Limited will be held on Tuesday, December 24, 2019 at 11:00 A.M. at the registered office of the Company situated at Plot No. 1, Phase II, GIDC, Dared, Jamnagar-361004, Gujarat to transact the following Special businesses;

 To increase the Authorised Share Capital of the Company and consequent alteration of Clause V of the Memorandum of Association of the Company:

To consider and if thought fit, with or without modification(s), to pass following resolution as **Special Resolution**:

"RESOLVED THAT pursuant to the provisions of Sections 61 read with Section 13, 64 and other applicable provisions, if any, of the Companies Act, 2013 (including any statutory modification(s) or reenactment thereof for the time being in force) and the rules framed there under, the consent of the members of the Company be and is hereby accorded to increase the authorized share capital of the Company from ₹ 6,00,00,000/- (Rupees Six Crore only) divided into 6000000 (Sixty Lakh) equity shares of ₹ 10/- each to ₹ 11,00,00,000/-(Rupees Eleven Crore only) divided into 11000000 (One Crore Ten Lakh) equity shares of ₹ 10/- each by creating additional 5000000 (Fifty Lakh) equity shares of ₹ 10/- each ranking pari passu in all respect with the existing equity shares of the Company;

RESOLVED FURTHER THAT, the consent of the members of the Company be and is hereby accorded for substituting existing Clause V of the Memorandum of Association of the Company with the following clause:

- An Explanatory Statement pursuant to Section 102(1) of the Companies Act, 2013, in respect of businesses to be transacted at the (EOGM NO. 01/2019-20) Extra-ordinary General Meeting (EOGM), as set out under Item Nos. 1 and 2 above is annexed hereto.
- A Member entitled to attend and vote at the Extra-ordinary General Meeting (EOGM) is entitled to appoint a proxy to attend and vote instead of himself and the proxy need not be a Member of the Company.

A person can act as proxy on behalf of Members not exceeding 50 (fifty) and holding in the aggregate not more than 10% of the total share capital of the Company. In case a proxy is proposed to be appointed by a Member holding more than 10% of the total share capital of the Company carrying voting rights, then such proxy shall not act as a proxy for any other person or shareholder.

The instrument appointing the proxy, in order to be effective, must be deposited at the

Company's Registered Office, duly completed and signed, not less than 48 (Forty-Eight) Hours before the commencement of the EOGM. Proxies submitted on behalf of limited companies, societies etc., must be supported by appropriate resolutions / authority, as applicable.

During the period beginning 24 hours before the time fixed for the commencement of Meeting and ending with the conclusion of the Meeting, a Member would be entitled to inspect the proxies lodged at any time during the business hours of the company.

- Members/Proxies should bring their Attendance slip duly completed for attending the meeting. The signature of the attendance slip should match with the signature(s) registered with the Company. Members holding shares in dematerialized form are requested to bring their Client ID and DP ID numbers for identification.
- 4. Corporate members intending to send their authorized representatives to attend the meeting are requested to send a certified copy of the board resolution authorizing their representative to attend and vote on their behalf at the meeting.
- In case of joint holders attending the meeting together, only whose name appearing first will be entitled to vote.


